#### **BACKGROUND**

The monthly Technical Services report has been identified by Council as the process of reporting the activities carried out monthly by the Technical Services Department.

# 1. TECHNICAL SERVICES AND ADMINISTRATION

Technical Services infrastructure, planning, design and surveys were carried out in-house. The Technical Services staff continue to provide customer service to the Gwydir Shire residents.

# 2. ENGINEERING SERVICES

#### Warialda Truck Wash

Road construction works on the truck wash facility were completed throughout December and January. This included extensive asphalting by a third party contractor. Maintenance staff erected all lighting for the facility (Solar LED) along with signage, security fencing and rock works to prevent erosion. A number of small items remain to be completed prior to officially opening the facility including minor landscaping, turf laying and commissioning a number of hose reels. Following a risk audit of the facility, it is planned to conduct a number of trial wash downs using local stock carriers to fine tune aspects of the facility such as water pressure and flow rates. While an official opening date has not been set, it is expected to be around the end of February.

# **Maintenance Grading**

Rainfall in January made it possible to recommence maintenance grading in a number of areas throughout the Shire. Where possible, graders operated on weekends in order to capitalise on the moisture. The following roads were graded in December and January:

- SR11 Horton Road
- SR 45 Bereen Road
- SR16 Trevallyn Road
- SR15 Gulf Creek Road
- SR23 Wearnes Road
- SR119 Woodburn Emelio Road

In addition to the above maintenance grading, re-sheeting was also able to occur in the north of the shire. Yallaroi Road received a 4km re-sheet replacing a bad sandstone section of the road with locally sourced basalt that was crushed in situ.

Four kilometres of Gragin Road was re-sheeted using material sourced from the property Ben Eden on the Gwydir/Inverell LGA border. This gravel is unique in that it is sedimentary in nature and has rounded rock. Crushing this material using Council's tractor-mounted crusher has delivered an extremely smooth pavement that is expected to have excellent durability.

- Footpath maintenance
- SR215 Nooroo Road replace headwall and pipeline
- Service requests
- Water deliveries

# Roads Maintenance Council Contract – Works Orders issued by RMS

All Work Orders issued by RMS are quality assurance schedule of rates projects carried out by Council staff under the Roads Maintenance Council Contract with Roads and Maritime Services.

A final design has been approved for segment 5340 on MR63 Fossickers Way. This segment is programmed to be rehabilitated in March/April 2020, now only awaiting the Work Order approval from RMS. These works will include widening the existing pavement, replacing the shoulders with a suitable road base material, extending and replacing pipelines, ripping and recompacting the existing pavement, and lastly placing a 100mm sub-base layer and a 100mm base layer over the top with a 7mm primer seal.

Works are well underway for the survey and design of three segments, programmed for rehabilitation next financial year. These segments include 5150 and 5255 on MR63 Fossickers Way and 8270 on HW12 Gwydir Highway. The survey works have been completed and draft designs for each segment are almost finalised, ready to be sent through for RMS approval. Further programmed works this financial year will include approximately four weeks of heavy patching throughout various segments, where required. A heavy patching program has been scoped out and a Works Proposal submitted to RMS, with works planned to start once a Work Order has been approved. No reseals are programmed for completion this financial year.

Routine maintenance continues each week undertaking inspections, rest area services, vegetation control and bitumen repairs.

Construction works are nearing the end for the Gwydir Highway intersection works onto the Warialda HPV Route. Crews have laid up to 1.6m of pavement fill to bring the proposed turning lanes up to the existing height of the Highway. Asphalt and bitumen have now been laid for the intersection, with a contractor delay prior to the Christmas break. Street lighting, guardrail and signage have also been installed. Remaining works include pouring the concrete traffic island and finalising the line marking, scheduled for completion in February. Once completed, a Road Safety Audit will be undertaken and the intersection can be opened.

#### Other Services

Street services continued to be maintained for vehicular, pedestrian and public conveniences.

Storm water drainage facilities continue to be maintained:

Aerodromes at Warialda and Bingara continue to be maintained and inspections are carried out monthly.

Existing quarry sources are continually being utilised and future sources are being investigated as time permits with other competing projects.

The radio and television towers continued to be maintained.

#### 3. DESIGN AND ASSET SERVICES

Survey, design and soil testing is continuing for the 2019-2020 works programs. Progress is as follows:

# North Star Road - Segment 310

The next section of North Star Road, which carries on north from last year's project for 2.2km, has had design completed. The project has been localised and is ready for construction to commence.

# Delungra Road

This section of Delungra Road runs from the Myall Creek Bridge back towards Bingara for 1.6km. The project has been designed and localised, ready for construction to commence next week.

# HPV Route and SH12 Intersection

This intersection has kept our survey and design team extremely busy over the December period! With the intersection consisting of eight different pavement layers, all requiring a conformance survey, the team had their work cut out for them. Throughout January, the survey team has been providing any final set out required for the project.

# Allan Cunningham Road - Linwood

This is the rehabilitation project for RMS this financial year. The final design has been completed, with localisation of the project still needed before construction commences.

# RMS Projects for Next Financial Year

With three separate RMS rehabilitation projects scheduled for next financial year, the design team has been busy designing and drafting plans to send to RMS for approvals.

# **Grant Applications**

The Engineering team has been busy with grant applications for Fixing Country Roads and Fixing Local Roads funding opportunities.

# Myall Creek Cultural Centre

The survey team has been assisting with set out at the Myall Creek Cultural Centre Site as required.

#### **GRAZING PERMITS**

As the Consent Authority for road reserves, Council has issued concurrence to the North West Local Land Services for six (6) Roadside Grazing Permits during the month of December 2019, and five (5) for the month of January 2020. Recent rains have improved the condition of the roadside stock route and stockholders are taking advantage of the ground feed available. The LLS has strict guidelines that only allows grazing where sufficient ground cover and pasture is available. 

#### **Pasture Conditions**


Monthly pasture growth rates - No Change - Growth rates are very low in the <10kg/ha range for the majority of the region.

\*Pasture biomass - No Change - Majority of the region remains below 250kgDM/ha (Aussie Grass).

\*North West LLS targets a pasture biomass of 1200kgDM/ha and pasture utilisation levels above 10cm as suitable for grazing.

<u>Ground cover</u> – <u>Decreasing</u> - Reduction in groundcover levels due to ongoing dry conditions.

<u>Combined Drought Indicator</u> – <u>Intensifying</u> - All of the region now has fallen into the 'Intense Drought' category.

# Status of Uses

Walking stock – Consideration of new applications for walking stock are currently deferred whilst under "Destination Only' conditions.

Drought Management movements - are permits of short duration and distance to allow:

- Walking stock between properties (Note: properties held by the same entity)
- Walking stock from a property to a saleyard
- Walking stock from a property to a feedlot
- Walking stock to confirmed agistment.

Short term grazing permits - will only be allowed where sufficient groundcover and pasture biomass is available as determined by the TSR Ranger. Roadside grazing permits - NWLLS permits roadside grazing use after the stock owner receives approval from the local Council. (Please note: Roadside Grazing Permits attract a permit fee)

Routine Stock Movements permits - Permits remain in place.

Long term grazing permits - Permits remain in place.

No significant change in stock numbers on TSR from the previous period (Sep-Oct 2019). This trend is expected to continue for the upcoming period (Jan-Feb 2020)




#### WASTE SERVICES


#### **Breakdown of Waste Collection**





# November 2019

This month throughout the month, we have put in place processes and tested them internally for accuracy so moving forward we have separate and accurate contamination records for each shire. In the Moree recycles shed we have setup a temporary divider (awaiting approval & Installation of a permanent divider) the new process will involve Moree / Gwydir recycles being unloaded into a designated area and decontaminated into separate bins clearly marked. These loads then go down to Narrabri individually and

Challenge are sent notification via SMS to advise what shire each load is from. At Challenge, each shire has their own area and separate contamination skip bins setup so they can also follow the same procedure ensuring each council has accurate figures. We are also following the decontamination process in our Organics facility to flow through with accurate reporting. Unfortunately, this month during the trialling stage, we also had a clean up happening in the yard and at the end of the month some of the contamination was loaded and send to waste facility with our internal rubbish. We have individual dockets for Narrabri & Gwydir so they have not been affected. However, Moree has been and this has been discussed with Tahra and averages worked out.

# December 2019

Recycling contamination is improving each month; we have been very consistent in our procedures over the past 3 months & following the contamination flowchart accordingly, which is giving us great results. We have also fully implemented the new decontamination measures in the recycles & organics facilities giving us accurate contamination weights for each shire accordingly.





# Water and Sewerage

During December and January, water operators attended 28 service line repairs, five water main breaks and 12 sewer blockages. Two major non-return valves at the Bingara Sewer pump station Number 3 were replaced. Work was undertaken on the Warialda truck wash bay, Bingara Civic Centre, Warialda Cemetery, Warialda treated effluent pumps, Maitland Street (Bingara) toilets, Naroo Hostel, Warialda swimming pool, Bingara swimming pool, CWA park toilets (Bingara), Bingara Museum, Roxy Theatre and Bingara Showground.

Boiled water alert was issued for Bingara water supply on 23rd January 2020 due to a rise in turbidity in the Gwydir River. The boil water alert was lifted on 30th January 2020 after three days of compliant water testing.

#### **Parks**

Parks, gardens, sports fields, cemeteries and Council facilities have been maintained during December/January. Watering programs have been developed and staff are rostered to start early to carry out watering, enabling Council to comply with level 1 water restrictions where possible. Broad leaf spraying was undertaken at various locations. A number of large street tree stumps were removed during December and January. All Abilities Park, Warialda had underground irrigation installed in January and turf will be installed during February to the next section of the park. A new irrigation line was installed at Gwydir Oval to water grass in front of the Grandstand and canteen area.

Drought relief casual employees have undertaken street furniture repainting in Bingara and fencing at the Living Classroom. Other projects include crowd control fence at Gwydir Oval, Oval seating repairs and town street maintenance.
