BACKGROUND

The monthly Technical Services report has been identified by Council as the process of reporting the activities carried out monthly by the Technical Services Department.

COMMENT

1. TECHNICAL SERVICES AND ADMINISTRATION

Technical Services infrastructure, planning, design and surveys were carried out in-house. The Technical Services staff continue to provide customer service to the Gwydir Shire residents.

2. ENGINEERING SERVICES

Warialda Truck wash

Council staff are working with Department of Planning, Industry and Environment (DPIE) to provide samples of waste discharge as a final step in seeking concurrence for the trade waste licence.

The MR134 Delungra Road Repair Program is completed. The project was 1.57km of full rehabilitation funded by the RMS under the Regional Roads Block Grant and Repair Program. The project was completed under budget and is a credit to Technical Services 'South' staff.

The 'North' Construction crew have completed 2.6km of rehabilitation on RR7705 North Star Road, funded under the Repair Program and Block Grant. The crew produced an excellent result in a very short timeframe, coming in under budget.

As a result of the cost savings made on the two Regional Road rehabilitation projects, Council will be undertaking a small rehabilitation project on Bruxner Way prior to the end of financial year. This will consist of a 1.5km long "super patch", which is effectively a large scale stabilisation of existing pavement. This is a low cost solution to road rehabilitation where there is already good pavement depth.

Roads Maintenance Council Contract – Work Orders issued by RMS

All Work Orders issued by RMS are quality assurance schedule of rates projects carried out by Council staff under the Roads Maintenance Council Contract with Roads and Maritime Services.

This is page number 6 of the minutes of the Public Infrastructure Committee held on Thursday 14 May 2020 Works have begun in segment 5340 on MR63 Fossickers Way. Crew members are currently widening the existing pavement, removing the unsuitable material from the shoulders and replacing it with a road base material. All culvert replacements and extensions have been completed. Remaining works will include ripping and re-compacting the existing pavement, and lastly placing a 100mm sub-base layer and a 100mm base layer over the top with a 7mm primer-seal. Works are expected to continue until the end of the financial year.

Design reviews are still in progress for three segments programmed for rehabilitation next financial year. These segments include 5150 and 5255 on MR63 Fossickers Way and 8270 on HW12 Gwydir Highway. Further programmed works this financial year will include approximately 4 weeks of heavy patching throughout various segments where required. Heavy patching works are now programmed to start towards the end of May. No reseals are programmed for completion this financial year.

Routine maintenance continues each week undertaking inspections, rest area services, vegetation control and bitumen repairs.

Other Services

Street services continued to be maintained for vehicular, pedestrian and public conveniences during April.

Storm water drainage facilities continue to be maintained.

Aerodromes at Warialda and Bingara continue to be maintained and inspections are carried out monthly.

Existing quarry sources are continually being utilised and future sources are being investigated as time permits with other competing projects.

The radio and television towers continue to be maintained.

3. DESIGN AND ASSET SERVICES

Survey, design and soil testing is continuing for the 2019-2020 works programs. Progress is as follows:

Myall Creek

The survey team has been required for the earthworks for the amphitheater at the Myall Creek Memorial Site to ensure that the levels are accurate in preparation for the next stage of construction.

Delungra Road

The survey team was also required on the Delungra Road Rehabilitation project. The team checked levels, marked the centerline and assisted with the Grade Control onsite. This project is complete and awaiting line marking.

MR63 – Linwood Project

The survey team also worked on the Linwood Project, along MR63, ensuring the Grade Control is working well and providing assistance where required.

4. TOWN SERVICES

Water and Sewerage

During April, Water and Sewerage operators attended 26 service line repairs, four water main breaks and six sewer blockages. Works were undertaken at the Bingara Cemetery, Gwydir Oval, The Roxy Complex, Naroo Aged Hostel, public amenities, and sewer pump stations No 2 and 3 in Warialda.

Level 1 water restrictions will continue during April and May 2020. The restriction has been modified so that no fixed sprinklers are permitted between 10am and 5pm, even though demand has reduced, it is considered good practice to be water wise.

Ten manholes in Warialda were refurbished during April; these manholes were identified from a previous asset inspection report. Contractors were used with specialist concrete applicator trailer and confined space entry equipment.

Electrical issues with one Gravesend bore, along with telemetry issues for Gravesend and Bingara water supply occurred in April. The telemetry issue is ongoing and will require major upgrade to ensure the system is reliable for the future.

Bingara sewer extension project for North and East Bingara has been progressing well with survey, environmental and engineering contractors carrying out various tasks in Bingara during April 2020.

Parks

All parks and gardens are being maintained. Council's playgrounds remain closed due to Covid-19 restrictions. Mowing, weed control, irrigation, hedging and trimming were all undertaken during April.

During April, Council's casual staff on the drought assistance program installed a fence around CWA Park playground in Bingara and installed pavers at the Bingara Cemetery columbarium area.

Gwydir Oval New Amenities Building

Concrete apron and footpaths were installed at the Gwydir Oval new amenities building in April. The internal plumbing has been completed, Colorbond roof installed, and crews started to clad the exterior of the broadcast box. The electrical and plastering will be undertaken early May. Once all the other works are completed the internal fit out of showers and toilets will be undertaken.

Showgrounds

The Bingara showground continues to be maintained. A grant proposal was submitted for additional lighting at the Bingara Showground through Regional Agricultural Shows grants program in December 2019. The outcome of this grant is expected to be announced in June 2020.

The new general purpose shed at the showground had minimal work undertaken during April as staff focus was on the Gwydir Oval amenities building.

Industry NSW released Phase 1 Stimulus Package for showgrounds for small projects that could be completed within three months of the grant funding announcement. Council submitted the following six small projects for consideration in this Phase 1 Stimulus:

RIVERSIDE CAMPING

Council's Compliance Officer aims to carry out daily checks along the Gwydir River to ensure that camping is being conducted in a safe and hygienic manner. Flyers promoting local events and services are distributed to campers and enquiries from campers are addressed as necessary. The graphs below show total numbers of campers and the distribution of campers at the different campsites.

The current restrictions imposed regarding the Covid-19 pandemic have seen bans imposed on all non-essential travel and the subsequent closure of campgrounds. While the campgrounds are officially closed there are some exemptions in place for people who were already set up on the campground on 1 April 2020. No new campers are currently allowed to set up at the campgrounds, and any existing campers have been encouraged to return home if possible or must remain in their existing position for the duration of the ban. There are currently 11 campers who have chosen to remain on site for the current time.

WASTE SERVICES

Scheduled kerbside collection of waste, recycling and green waste was carried out throughout the Shire. Customer service requests are processed and actioned as necessary.

All Waste Recovery Centres in the Shire continue to be supervised/monitored and maintained. Staff continue to make changes to the site layout and signage to improve onsite operation and access for residents unloading waste and recyclable materials. Council is continuing to supply mulch from chipped green waste to residents.

CONTAMINATION REPORTING

Cleanaway has refined the collection of their contamination data and now reports on contamination rates for each Council area (Moree, Narrabri and Gwydir). This gives an accurate reflection of the contamination rate for waste generated within the Gwydir Shire area, rather than the previously reported statistics, which were unable to accurately report which LGA was experiencing problems with contamination in the recycling and organics waste collections.

The graphs below show contamination rates for both the Gwydir Shire and the combined collections area for the month of March compared to the previous three months, noting that there is some overlap of data collected prior to January 2020.

The Priority Weeds Unit is happy to welcome Council's newest Bio-Security Officer to the team. He has come to the Weeds Team after previously working in Parks and Gardens in Bingara, and will be working closely with the current Bio-Security Officers to become familiar with the requirements of the position. The role requires undertaking weed control and property inspections across the Shire. He was welcomed aboard during a brief team meeting (no handshakes were made and social distancing was observed) and welcomed to his new role.

BUILDING MAINTENANCE

The Department continues to receive requests to carry out minor maintenance and these are generally dealt with in a timely manner. Otherwise the works are scheduled into maintenance staff building activities including new works for attention.

Staff worked on the following projects during April:

- Bingara Showground all purpose pavilion 75% of work is complete.
- Gwydir Oval amenities 75% of work is complete.
- Bingara Visitor Information Centre completed painting.
- Bingara Museum 20% of work is complete.
- General Repairs and Maintenance.

EMERGENCY SERVICES

Warialda is in a high bush fire prone area and is identified in RFS's Risk Management Plan at Very High Risk.

Gwydir Shire Council was successful in receiving funding for the Hazard Reductions (HR) works this year and is being prioritised for mitigation works to address the risk.



During April, contractors have been completing trittering (slashing) works around the township of Warialda to create Assets Protection Zone (APZ). This has involved the removal of all black pine, no greater than three metres in height or greater than 300mm in girth, being removed as required in the Bush Fire Hazard Reduction Certificate conditions. A maximum distance of six metres from the boundary border has been completed around the sections marked with a black circle on the map. Once the trees have been mulched to the ground a slasher is then used to distribute the mulch in an even spread of ground cover, leaving the area looking tidy and adhering to the conditions of the permit to maintain at least 75% ground coverage.
